CONSTITUTION AND BYLAWS COMMITTEE

Article XI of our Chapter's existing bylaws outlined the procedure to be followed in amending our bylaws. It calls for the proposed amendments to be mailed to all members of the Chapter not less than 15 days before the next meeting at which time approval of the amendments shall be gained if two-thirds (2/3) of the voting members present vote favorably.

Following this procedure would result in reproduction and mailing costs to our chapter of approx. \$370.00. Upon approval and acceptance of the amended bylaws by Society, the Chapter will be faced with a similar expenditure to reproduce and mail copies of the revised bylaws to each member. If not approved, as was the case with our 1975 submission, further similar costs would be incurred.

With this in mind, your president acting on the advice of Lorne Wilson, Chairman of our Chapter Constitution and Bylaws Committee and with the approval of the Board of Governors, called a vote of the members at our October meeting for approval of a procedural change. Instead of automatic mailing, copies of the proposed revised bylaws would be made available through our secretary to any interested member who requested one prior to our November meeting. It was felt that this procedure meets the intent and spirit of the bylaw if not the letter. This vote carried by a two-thirds (2/3) majority.

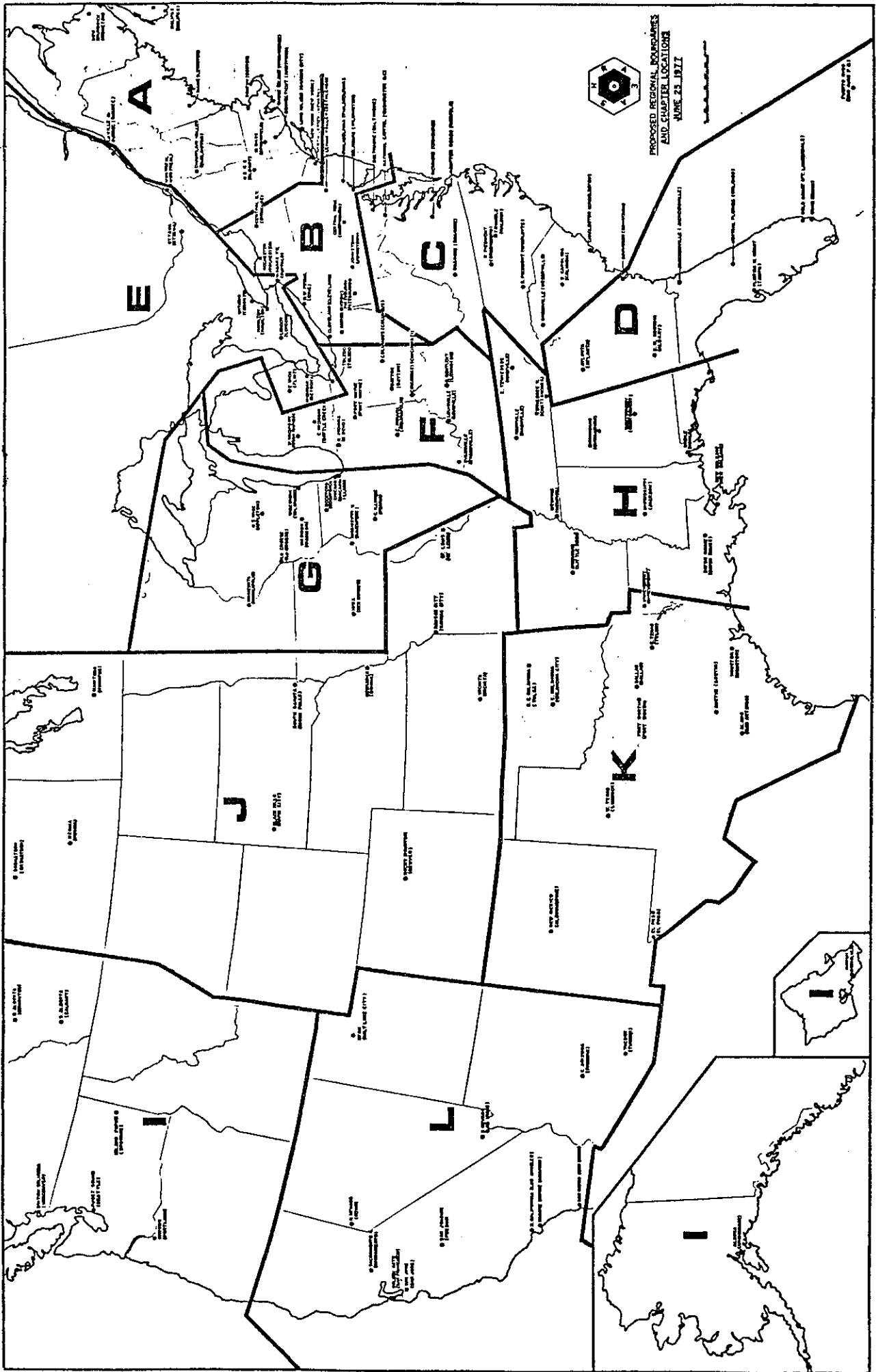
After the vote had been taken, Jake Klassen, leading dissenter who is also Chairman of the Society Charter and Bylaws Committee stated that part of his opposition to the procedural vote was that his committee have once again revised the model bylaws and our proposed revision is out of date. With this knowledge, Lorne Wilson recommended to the Board of Governors that the revised bylaws be withdrawn and that no vote be taken at the November meeting.

The Board of Governors has accepted this recommendation and have instructed Lorne Wilson to work closely with Jake Klassen to develop a new set of revised bylaws that can hopefully gain chapter membership and Society approval at the June annual Society meeting.

STOP THE PRESSES!

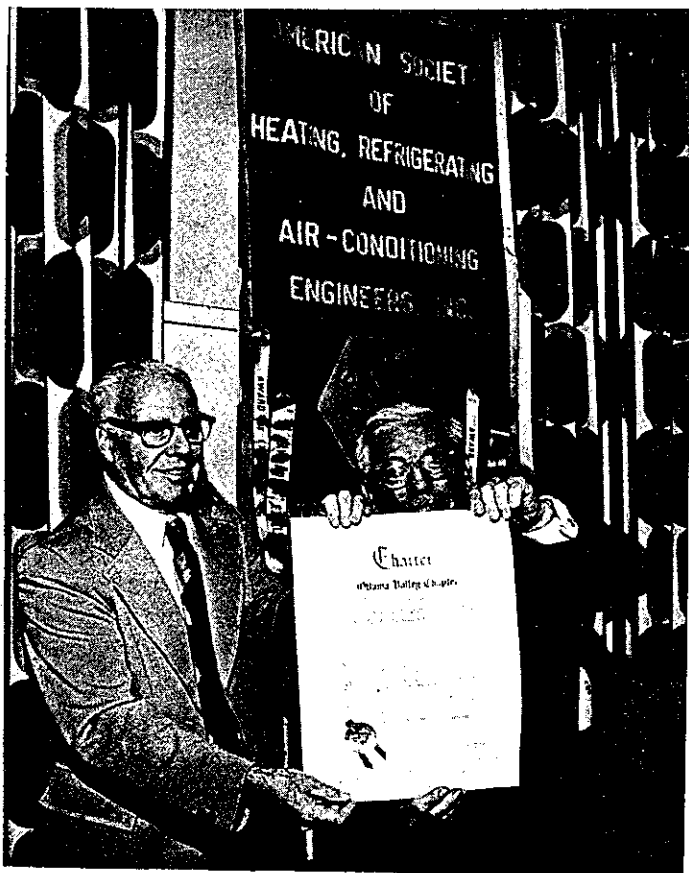

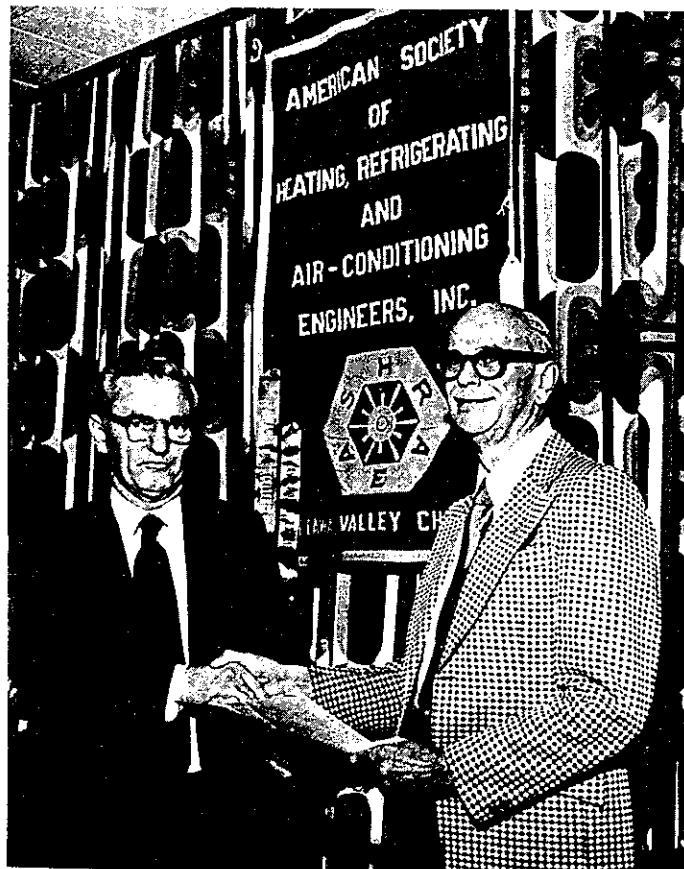
